1971 County information shows the corner is at the centerline of a north/south and east/west road with the following reference ties:

1978 Paul Wellen, LS 10461, found a 1/2" pipe at the intersection of the centerline of a township road north/south and east/west. He filed a Certificate of Location (#151866). Ties to 3 Pine trees.

1981 County information shows a solid 1" steel pin marked the corner with the following reference ties.

2001 Brown Herkenhoff, Inc. notes a found 1 1/2" iron pin at the corner. Measured 2661.01 feet to the NW corner and 2657.23 feet to the NE corner of Section 22.

2008 Westwood Professional Services, Inc. found a 1 1/2 " square iron pin fitting two of the 1981 ties and coordinates obtained by GPS coincide with 2004 MN/DOT position. Measured 2661.00 feet to the NW corner and 2657.45 feet to the NE corner of Section 22. 1 1/2" square iron pin is accepted as marking the obliterated position for this corner.
