

Statement of Evidence:

Northeast Corner of Section 35, Township 36 North, Range 31 West, Sauk Rapids Township, 4th Principal Meridian, Benton County, Minnesota.

1850 Original US General Land Office survey notes that a wood post was set and bearing trees were recorded:

14" Bur Oak	N 88 W	439 links
12" Bur Oak	S 57 W	458 links

1913 County Surveyor's Record Book, pages 36 and 37 and pages 40 and 41, contains surveys in Section 35 by J. A. Stanton. Survey shows corner being found on RR right of way about 25 feet from the westerly R/W line and marked by a piece of gas pipe 1 1/2 " in dia.

Undated County Surveyor's Record Book 1, page 285, notes an iron pin at the corner, a distance of 2629.0 feet from the South 1/4 Corner of Section 25.

Roll D-7 and Roll E-3 of the MN/DOT road alignment plans note an iron pin at the corner and Roll E-3 notes a distance of 1803.1 feet to the centerline.

1972 An iron is noted at the corner with the following reference ties.

1981 William Lunser, LS 9394, found a 3/4" iron pipe and replaced it with a cast iron monument and filed a Certificate of Location (#158858).

1994 Westwood Professional Services, Inc. (Brainerd office) found a cast iron monument with the top broken off west of the most westerly track. Ties found in good condition are:
