Registrants Among Us

- Registrants and those with a history of sex offending have always lived in our communities
- It's likely they live, work, and interact in every community in Minnesota



Registration

Established July 1, 1991

Administered by the MN Bureau of Criminal Apprehension (BCA)

Contents of registration:

- Addresses
- Employment
- School/vocation
- Vehicles

Registration

Registration is required if an individual is convicted, charged, or adjudicated delinquent for specific crimes:

- Criminal Sexual Conduct
- Any sexual conduct involving a minor, including possession of Child Sexual Abuse Images (CSAI).
- Kidnapping
- False Imprisonment

Registration

As of January 1, 2023, there were approximately **18,288** people required to register in Minnesota

- As of March 13, 2023:
 - **114** registrants in Benton County (2)
 - **97** registrants in Morrison County (3)
 - **182** registrants in Sherburne County (1)
 - **413** registrants in Stearns County (6)

Community Notification

- Established January 1, 1997
- Minn. Stat. § 244.052

Community Notification

Applies to:

- Registrants released from prison
- Registrants from other states or federal jurisdiction who were released from prison (including military)
- Those civilly committed for sexual offense behavior

Does not apply to:

- Those with juvenile registration offense only
- Registrants sentenced to probation only

Community Notification

Department of Corrections

- Responsible for assessing risk and assigning risk levels

Law Enforcement

- Responsible for community notification
 - *Scope of notification based on assigned risk level*

Risk Levels

- Level 1 - Lower Risk
 - Law enforcement may notify other law enforcement agencies
 - Law enforcement shall notify victims and witnesses of the offense
 - Law enforcement shall notify adult household members

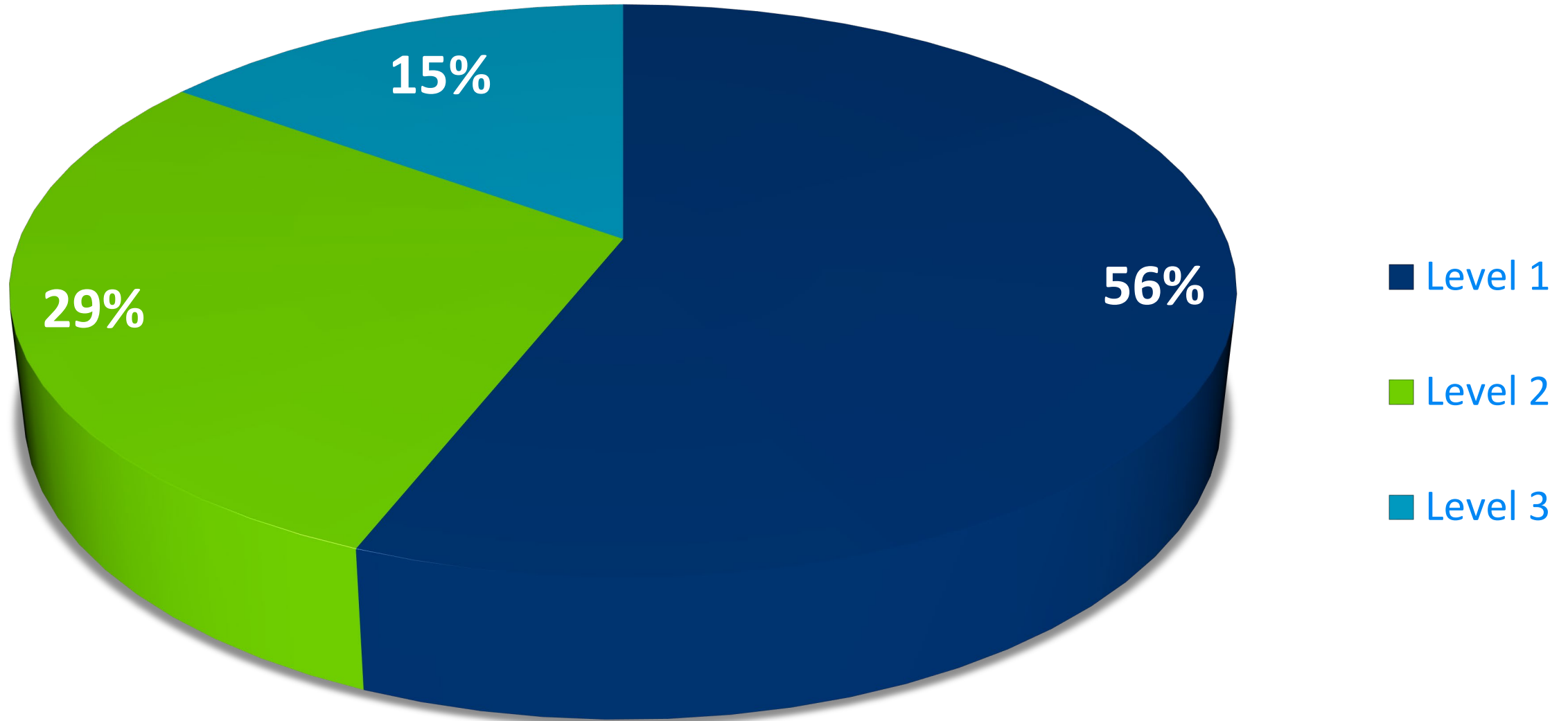
Risk Levels

- Level 2 - Moderate Risk
 - In addition to Level 1 notifications, law enforcement may notify individuals or organizations based on the registrant's particular offense pattern or history

Risk Levels

- Level 3 - Higher Risk
 - Broad public notification/disclosure
 - DOC public registrant website
 - Public notification meeting
 - Media (newspaper, radio, television, etc.)
 - Agency website
 - Social media
 - Door-to-door flyers

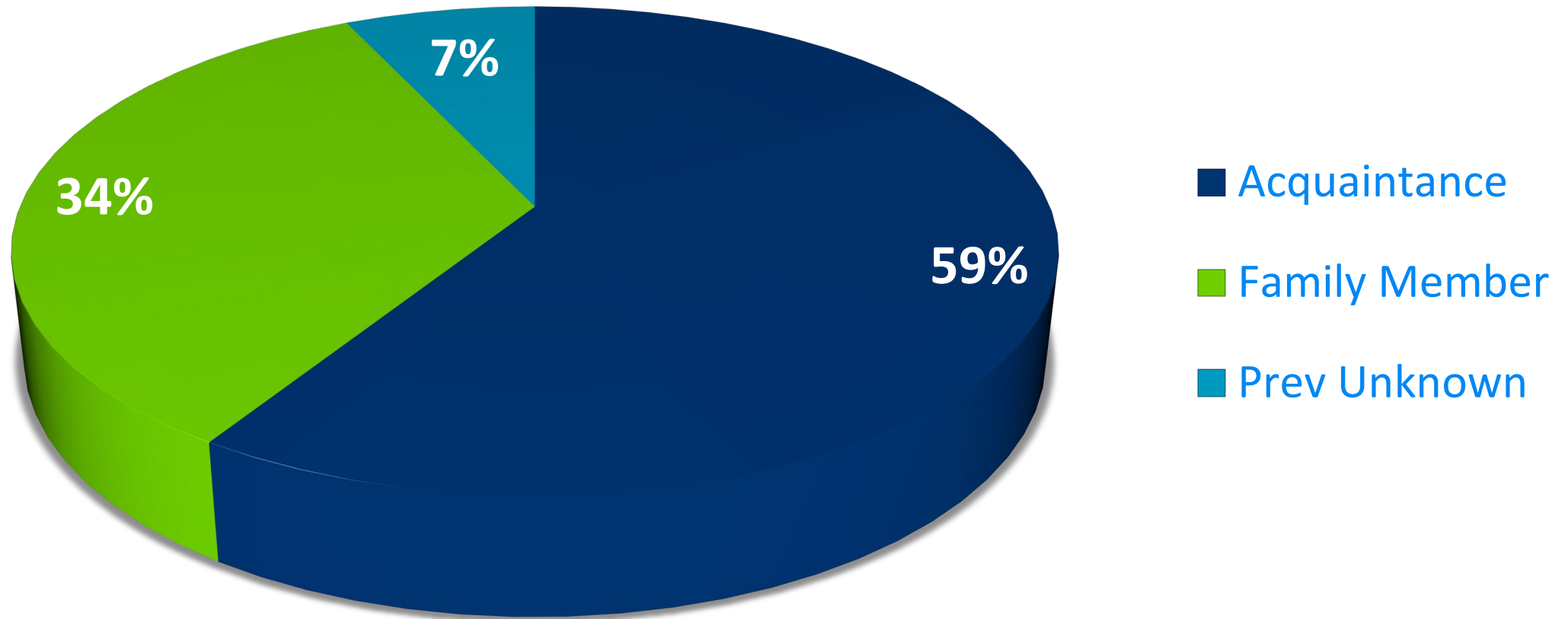
Current Risk Levels



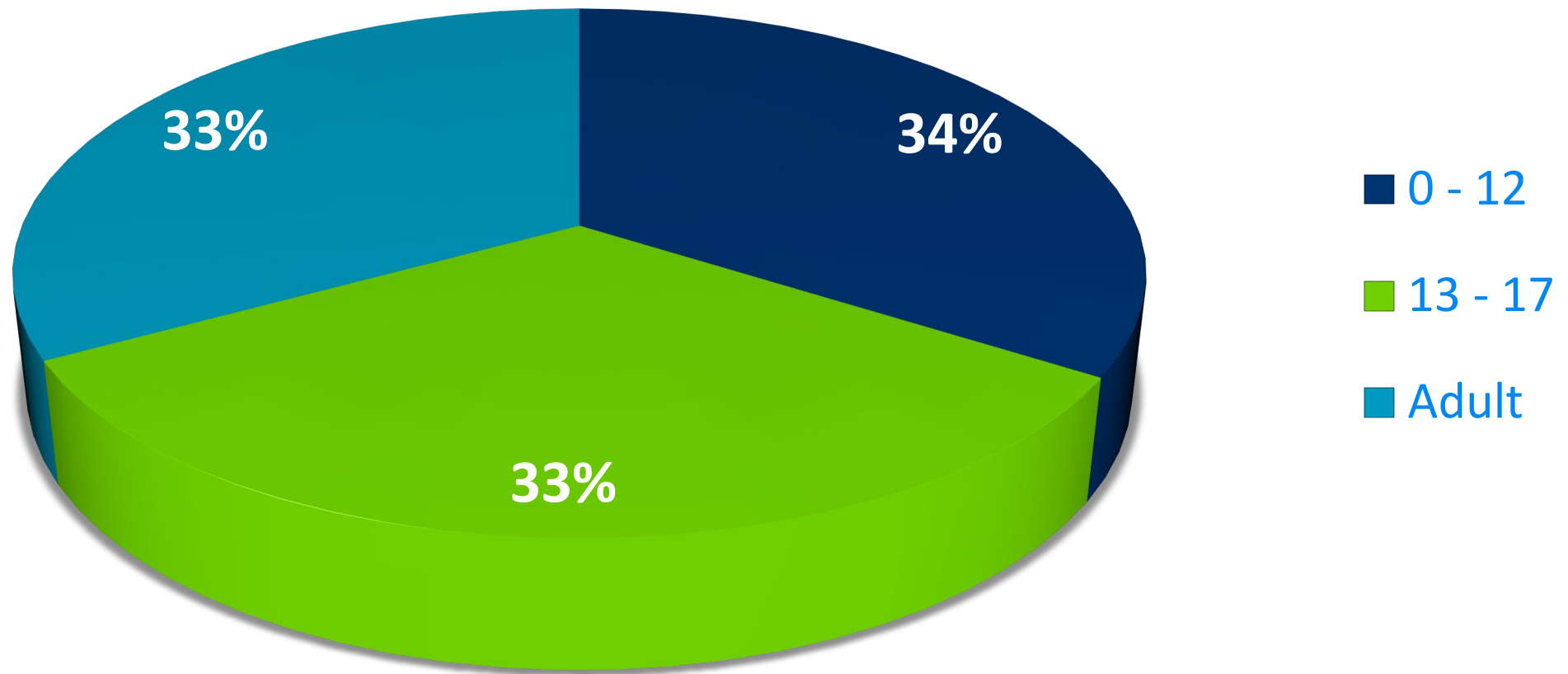
Those subject to broad public disclosure

- As of January 17, 2023, there were **439** registrants subject to broad public disclosure residing in Minnesota communities.

Children and Teen Victims Know the Perpetrator

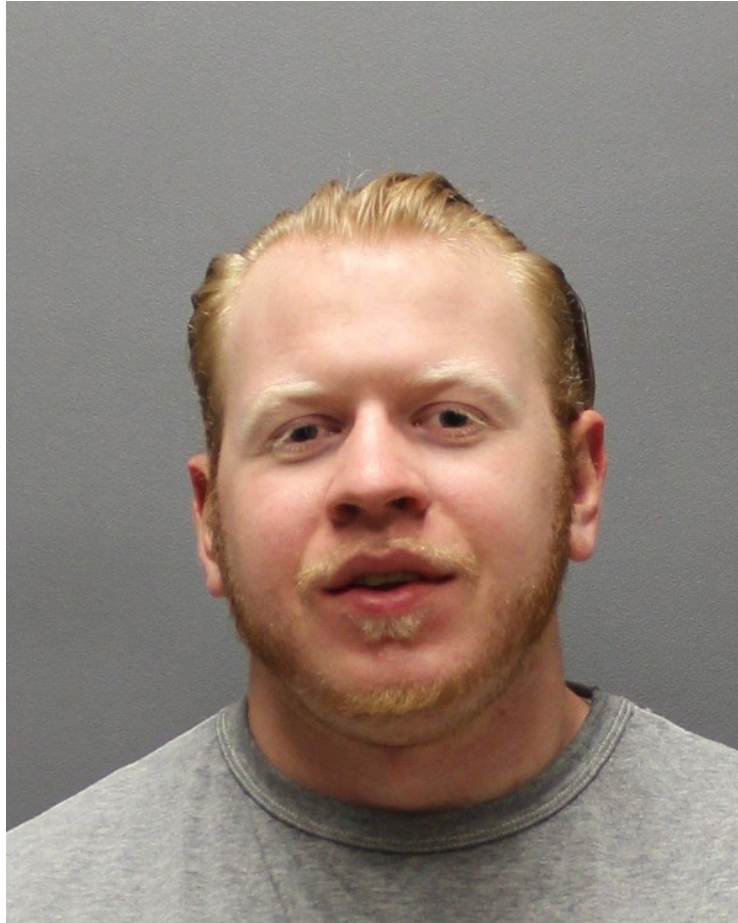


Age of Victims

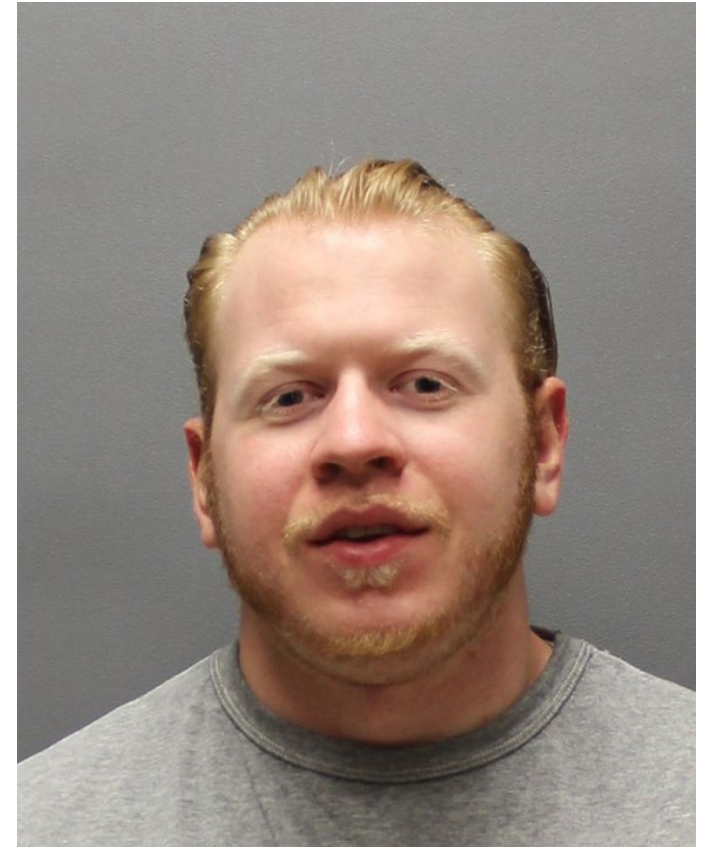

Registration Offense History:

Engaged in sexual contact in 2012-2013 with previously unknown female teenagers (ages 14-17). Contact included sexual touching and penetration. Rahm gained access by meeting them online and after meeting up with them subsequently used force to gain compliance.

Brent Christopher RAHM

2014: Criminal Sexual Conduct 3rd Degree, Mille Lacs Co.

- Criminal sexual contact against a 15-year-old female in Oct 2012 (Rahm was 20)
- Previously unknown to victim
- Contact originated via social internet interaction with friend of the victim
- 27 Month commit - Conditional release of 10 years — 368 days credit for time served

Brent Christopher RAHM

2014: Criminal Sexual Conduct 4th Degree, Sherburne Co.

- Criminal sexual contact against a 17-year-old female in Nov 2012 (Rahm was 20)
- Previously unknown to victim
- Contact originated via social internet interaction. Subsequently after meeting in person used force to commit sexual assault including penetration.
- 48 Month commit - Lifetime conditional release period – 409 days credit for time served

Brent Christopher RAHM

2014: Criminal Sexual Conduct 3rd Degree, Mille Lacs Co.

- Criminal sexual contact against a 14-year-old female in July 2013 (Rahm was 21)
- Previously unknown to victim
- Contact originated via social internet interaction. Behavior included sexual interactions with a number of 14 and 15-year-old minors at a campground.
- 60 Month commit, Life-time conditional release period (429 days credit)

Brent Christopher RAHM

May 2014 - entered prison

09/06/2017 released to intensive supervision as **RL 3**

11/14/2017 revoked (failure to progress in treatment, unapproved media access);

04/30/2018 released to intensive supervision

10/16/2018 revoked (unapproved activities and contacts);

12/03/2018 released to intensive supervision

03/19/2019 revoked (failure to progress in treatment and unapproved activities including media);

March 16, 2023 – will be released back to intensive supervision.

Supervision and registration requirements

- Mr. Rahm will be under correctional supervision for life.
- He will also be subject to registration for life.

Intensive Supervised Release (ISR)

MN Statutes 244.12 – 244.15 (1990)

- Primary objective is public safety
- Compliance with release conditions
- Successful reintegration to the community

Intensive Supervised Release (ISR)

Release Planning Process

- Collaborative effort by institution staff & agents
- Identify options for a safe, stable, supportive environment minimizing risk factors and maximizing protective factors
- Placed on GPS
- Released from the facility to an ISR agent
- ISR agent transports offender to approved residence
- Successful reentry is the goal

Intensive Supervised Release

- ISR operates 24/7/365
- Highly structured
- Reduced caseload size
- Frequent face to face contact
- Random, unannounced visits
- Daily contact

Awareness and Education

- The Three 90's
 - 90% do not reoffend
 - 90% known to victim
 - 90% not previously convicted
- And the Two R's
 - It's about *relationship* not *residence*
 - Social proximity is more important than geographic proximity
