

## Executive Summary


Benton County continues to be a safe and welcoming community. For the 6<sup>th</sup> year in a row, the crime rate and number of reported crimes has fallen in the unincorporated areas where our office holds primary jurisdiction. Three of the top five most reported crimes are property crimes, with domestic violence demonstrating an unexpected upturn in reported incidents.

Recruitment and retention of qualified staff, particularly in our licensed deputy and jail positions, continue to be a focus of our work. Quality public safety service is dependent upon finding and hiring good people. Our current labor shortage has made this part of our work extraordinarily difficult and an important part of our daily activities. To help address this, we have instituted employee wellness programs intended to support and retain the talented people currently serving our community.


Office metrics demonstrate normal fluctuations in their measurements without any drastic movements of significance. Community outreach and crime prevention efforts remain a primary focus. An engaged and involved community is our best


**ICRs by Year**




**Crime Rate by Year**



**Incoming calls in the PSAP**




**911 Calls in the PSAP**




defense against crime in our neighborhoods. It is our hope that the information contained within this report will aid in generating a closer connection to the people and the communities we serve.


### **Patrol Division Calls for Service**




### **Civil Process Service**





## **Annual Report**

There are many stories to be told within the statistics found in the 2023 annual report. Individual metrics, when compared to 2022, demonstrate normal fluctuations in these measurements without any drastic movements of significance. Among the metrics that increased in 2023 are the number of calls processed, number of 911 calls taken, civil process papers served, assigned patrol division calls, and jail average daily population. The metrics demonstrating a decrease include text to 911 sessions, arrest warrants received, and cases assigned to detectives. All of these metrics are within a normal range of fluctuation and have no consistent long-term trend. The exception to this rule is our crime rate and actual reported crimes. For the 6<sup>th</sup> year in a row, the unincorporated areas of Benton County enjoyed a decreasing crime rate and decreasing number of reported crimes. We believe the key to this trend is the diligent work done by the members of this office and the crime prevention steps taken by the citizens of Benton County. One area of focus called out by this report is the rise in the number of domestic violence related calls. It remains to be seen if this is the start of a trend or a short-term anomaly. Regardless, addressing this crime will continue to be an emphasis going forward for our office.

Shortages of qualified candidates who meet the standards required of those who work in public safety continues to be a significant issue our office and law enforcement statewide battles. Candidate pools for licensed peace officer positions grow shallower every year. We continue to see declining enrollment in law enforcement programs throughout the state, raising concerns of a coming critical shortage of peace officers. Recruitments for non-licensed positions prove to be equally challenging as workers find a wealth of opportunities when deciding where they wish to obtain employment. The peace and safety enjoyed by the people of Benton County is dependent upon talented individuals stepping forward to serve and better their communities.

### **Mission and Vision statements**

The mission of the Benton County Sheriff's Office is:

To keep Benton County safe by enforcing laws, providing public safety services, and building community partnerships with respect and integrity.

Our vision for Benton County:

The Benton County Sheriff's Office strives to reduce crime and build community trust while ensuring accountability to the people we serve.

### **Public Safety Answering Point services**

The Public Safety Answering Point (PSAP), also known as the dispatch center, is the first point of contact for a majority of the public who are seeking public safety assistance. The Benton County PSAP answers not only incoming 911 calls but also administrative calls for the Benton County Sheriff's Office, Foley Police and Fire departments, Rice Police and Fire departments, and Sauk Rapids Police and Fire departments. Once a call or request for service is received, the PSAP dispatches appropriate emergency services using the public safety radio system. The calls received in dispatch which generate a public safety response for any of the agencies in Benton County are recorded on an Initial Complaint Report (ICR). In 2023, the Benton County PSAP generated 27,528 ICRs. This was 905 more ICRs than 2022. The time from 9:00 am to 11:00 pm generated the highest number of ICRs with the time period from 1:00 pm to 8:00 pm representing the peak hours. Of the 27,528 ICRs made in 2023, 10,962 were generated between 1:00 pm and 8:00 pm, representing 39% of all calls. Fridays generated the most ICRs in the PSAP, while Sundays generated the fewest ICRs. The months of May through September were the busiest months in the PSAP. In 2023 the PSAP received 9,778 calls on our 911 lines, 402 more than in 2022. Since 2017, Minnesotans have been able to send text messages to 911. In 2023, our PSAP handled 34 text-to-911 sessions, 53 fewer than in 2022. The PSAP also fielded a total of 41,351 incoming and outgoing telephone calls on our administrative telephone lines, 302 fewer calls than in 2022. Of these calls, 24,541 utilized one of the 6 non-emergency lines for the Sheriff's Office and 6,193 came in on 320-251-9451 (the main published non-emergency number for the Sauk Rapids Police Department). The volume of telephone calls was highest in the months of May through August. The time period between 8:00 am and 7:00 pm saw the highest volume of telephone calls in the PSAP.

### **Civil Process and Warrant division**

One of the statutory duties of the sheriff is to serve and execute civil papers, court orders, and arrest warrants. In 2023, the sheriff's office received 945 requests to serve civil process, 180 more than 2022. Legal process related to orders for protection and harassment orders dominated the work, making up 200 of the 945 requests. The next 5 most common classes of legal process were summons and petitions, order to show cause, subpoenas, writs of recovery, and eviction summons. The sheriff's office conducted 18 mortgage foreclosure sales in 2023, four more than in 2022. For the year, 1,269 arrest warrants were received in the sheriff's office, 178 fewer than in 2022.

### **Patrol Division**

The most visible and recognizable division in the Benton County Sheriff's Office is the patrol division. These are the uniformed deputies on patrol who respond to calls for service, investigate crimes, and perform proactive patrols. In 2023, 15,344 ICRs were assigned to units within the Benton County Sheriff's Office (1,150 more than in 2022), most of which were handled by the patrol division. Traffic stops accounted for the single largest category of activity for the patrol division in 2023. Assistance to the public and other agencies, medical emergencies, suspicious activity reports, vehicle-related incidents and alarms were the next 5 most common functions performed by the patrol division. The 5 most reported crimes in Benton County in 2023 were Domestic Violence, Fraud, Theft, Harassment, and Criminal Damage to Property. The majority of ICRs assigned to our office were generated between 8:00 am and 6:00 pm, with a spike in calls for service between 2:00 pm and 5:00 pm. Fridays saw the most activity within the patrol division with Sundays showing the least activity. May, June, and July represented the busiest months for calls within the Patrol Division.

In 2021, the Minnesota Bureau of Criminal Apprehension (BCA) made changes to the system used by criminal justice agencies when reporting crimes. Prior to 2021, crimes were broken down into Part 1 crimes and Part 2 crimes. Part 1 crimes were the most serious offenses and include violent crimes against a person. Part 2 were less serious offenses and include some person offenses and less serious property crimes. In 2021, the BCA instituted the Minnesota Crime Data Explorer system, changing these crime categories to Group A crimes and Group B crimes. Group A crimes include serious crimes against a person, property, and society. Group B crimes are less serious crimes and include:

The BCA does not provide a means to access agency-specific statistic on Group B offenses. Due to this limitation, this report is only able to comment upon trends in Group A offenses. According to the 2022 data set from the Minnesota Crime Data Explorer, Benton County's Group A crime rate<sup>1</sup> was 2,328. The 2022 BCA Uniform Crime Report reported Minnesota's overall crime rate was 4,598, meaning that Benton County's Group

<sup>1</sup> "Crime rate" is a term used in evaluating criminal statistics. It is the number of crimes reported by law enforcement per 100,000 in population.

A crime rate in 2022 was 49% lower than the state average in 2022. An examination of 2023 data from the Minnesota Crime Data Explorer showed Benton County's Group A crime rate declined to 1,723. Statewide crime rate data for 2023 is not yet available. This marks the 6<sup>th</sup> consecutive year of a declining crime rate in Benton County.

Within the 14,172 ICRs assigned to the Benton County Sheriff's Office staff are a number handled by administrative or support staff. These include records checks (402), permits to carry a pistol (697), and permit to purchase a pistol (168). For 2023, our applications for permits to carry were up by 10% and our applications for permits to purchase were up by 4% when compared to 2022 numbers.

### **Investigative division**

The investigative division of the Benton County Sheriff's Office is tasked with investigating and solving felony level crimes and other crimes requiring more in-depth examination. In 2023 there were 110 cases assigned to this division, a 29% decrease from 2022. Of those 110 cases, 97 cases were cleared, creating an 88% clearance rate for the Investigative Division. The Investigative Division is also tasked with receiving and securing items of evidence at the Benton County Sheriff's Office. In 2023, the evidence room received 679 items.

### **Violent Offender Task Force (VOTF)**

The Benton County Sheriff's Office is a participating member of the Central Minnesota Violent Offender Task Force. This group of investigators work on in-depth investigations aimed at arresting the most dangerous and violent criminal offenders. Much of their work is focused on combating drugs and gang activity in Central Minnesota. As sheriff, I have stressed to our two full time staff members assigned to this unit the importance of working long term investigations aimed at arresting those who distribute the largest quantities of illegal drugs and those who are at the highest echelon of leadership in local criminal gangs. These investigations require time and patience, which is often difficult to express in terms of numbers. VOTF investigators continued to see a steady supply of controlled substances coming into Benton County and a steady demand for them as well. Methamphetamine continues to be the most commonly found controlled substance in VOTF investigations, however fentanyl remains a growing threat to the area. Fentanyl, more than any other street drug, results in far more fatal or near fatal outcomes for users. In 2023, VOTF investigators completed 15 cases in Benton County. VOTF investigators executed 12 search warrants, seized 3 firearms and almost \$10,000 in cash associated with controlled substances, and participated in a case that

resulted in the arrest of a suspect for 3<sup>rd</sup> Degree Murder. During 2023, VOTF investigations in Benton County purchased or seized 24 pounds of methamphetamine, 2.71 pounds of cocaine, 1.94 pounds of powder fentanyl plus an additional 253 fentanyl pills, and 8.6 grams of psilocybin mushrooms. As part of our crime prevention efforts, VOTF investigators conduct educational presentations to the community on the dangers of drugs and the current trends in the world of drugs and gangs.

### **Jail division**

For 2023, the jail had an average daily population (ADP) of 48.6 inmates, an increase of 1.38 ADP compared to 2022. This marks the third year in a row of increasing ADP. The jail booked in a total of 1,581 inmates in 2023, 14 fewer bookings than in 2022. Of these 1,581 inmates, 1,217 of them were males and 364 were females. The average length of an inmate's stay in 2023 was 11.22 days, an increase of 0.41 days when compared to 2022.

Recruitment and retention continue to present challenges to staffing levels in the jail. Our staffing levels in 2023 fared better than in 2022. A reduction in the number of employees leaving coupled with continuous diligence in filing vacancies resulted in position vacancy rates between 10% and 15% for the year. The labor shortage and challenges of the work environment still make detention officer a very difficult position to fill.

Like all jails across the state, Benton County struggles to cope with the influx of inmates battling mental illness. Managing individuals with mental illness in a jail setting presents a challenge for staff to maintain the safety and security of both the inmate and the safety and security of our staff. Individuals with mental illness can engage in unpredictable, unhealthy, and sometimes violent behavior. Unless this societal issue is addressed in meaningful ways, we anticipate that jails will continue to be a repository for under-served individuals with mental illnesses to languish in a facility that was neither designed nor intended to treat them.

In an effort to recoup some of the costs associated with housing prisoners, the Benton County Jail charges a booking fee, a work release fee, and (for inmates serving a sentence after being convicted) a daily boarding fee. For 2023, the jail collected a total of \$33,549 in these fees. To make the most efficient use of the jail space in our facility, the jail boards inmates for other criminal justice agencies for a daily fee. For 2023, the jail collected just over \$72,000.00 in jail revenues from prisoner boarding.

Our Sentenced to Service (STS) crew transitioned from a state-based program to a county-based program in 2021. In 2023, the STS crew worked on 31 projects within Benton County. These projects included work performed for Benton County, the cities of Rice and Sauk Rapids, Watab Township, the Benton County Agricultural Society, and the Foley School District. Eleven inmates performed work on the STS crew, working off 75 days of jail time and \$2,720.00 in fines in 2023.

### **Volunteers**

The Benton County Sheriff's Office is fortunate to have dozens of citizens who are willing to volunteer their time to assist us in our mission in a number of ways.

The Benton County Mounted Patrol is a volunteer organization whose mission is to use horses and riders in providing assistance with crowd control, search and rescue, and other law enforcement functions. This group puts in many hours of training to ensure their readiness for such missions. The Mounted Patrol also provides security at the Benton County Fair and other similar events in the county. In 2023, Mounted Patrol members worked a total of 406 hours.

The sheriff's office maintains a group of citizens who serve this office and our community as reserve deputies. These non-licensed volunteers assist in several capacities, such as providing traffic direction, performing winter cabin checks, staffing entry points at the county fair, and several other duties appropriate for non-licensed staff. In 2023, the 9 volunteer reserve deputies performed a total 510 hours of service on various projects.

The sheriff's office also has approximately 88 individuals who volunteer in the jail to assist with various programs provided to the inmates. In 2023, these volunteers performed 954 hours of work in programs in the jail. The Benton County Sheriff's Office is very grateful for the assistance provided to our mission by these volunteers.

### **Public outreach**

Our outreach efforts are an important part of a proactive approach that aims to prevent future problems and build rapport between law enforcement and the community. In 2023, 526 DARE students in six Benton County schools were presented with the DARE curriculum. Our Police Activities League program continued in 2023 as a great opportunity for our staff to work with Foley and Rice police officers in building rapport with children aged 5 to 15 on a weekly basis throughout the summer. Our office also hosted full classes of Youth Snowmobile and Youth ATV certification courses.

### **Social Media and Print Media**

In 2023 the Benton County Sheriff's Office continued to make use of our Facebook, Twitter, and Nextdoor accounts to distribute information and crime prevention strategies. For those not already following us, our Twitter account may be found @BentonMNSheriff and our Facebook page is found at Facebook.com/BentonMNSheriff. Our audience on all of these social media platforms continues to grow regularly. On a number of occasions, we have successfully used social media to obtain leads on criminal investigations and locate individuals with active warrants. In 2023 our office continued our partnership with the Benton County News and Sauk Rapids Herald to provide a once monthly column on crime prevention and safety topics. The goal of this column is to enhance the safety of Benton County citizens by reaching out to a wider audience with our crime prevention messages. We hope to use these tools to help make Benton County a safer place.


### **Officer-involved shooting incident in Glendorado**

The 2023 annual report would not be complete without pausing to recognize the extraordinary circumstances that unfolded in Glendorado in October. On October 12<sup>th</sup>, a suspect in a drug investigation opened fire with a rifle on peace officers from our office and the Sherburne County Drug Task Force as they were serving a search warrant at his Glendorado home. Five officers were struck by gun fire, three of whom sustained serious injuries. Thanks to the extraordinary efforts of dozens of law enforcement officers, paramedics, and firefighters, the injured officers were rushed to the hospital and the suspect was ultimately arrested. All three injured officers continue to heal from their injuries. In recognition of their outstanding and heroic efforts during the initial moments following this assault, four members of our office were awarded special honors. Deputy Ron Thomas was awarded the Medal of Honor, Deputy Cody Eisenschenk was awarded the Medal of Valor and the Life Saving Award, and Public Safety Dispatchers Dawn Riggs and Justin Wendland each received the Meritorious Service Award. We are extremely proud of the efforts of these four individuals and the rest of the first responders who put their lives in danger to ensure public safety was maintained.










**2023 Total 911 Call Volume Per Year**






## Calls for Service Yearly






## Calls for Service Day Of Week


